# CASI Awards Four Scholarships

Seventy students from 8 states applied for a CASI scholarship this year. Because of the number and the outstanding achievements of these applicants, the Scholarship Committee had a difficult assignment. Twenty-five (25) of the applicants received a final ranking of from one (1) to five (5), ending up with a tie for the third (3rd) top place. I contacted the CASI treasurer and explained the situation, along with my recommendation for solving it. It was decided to award four (4) scholarships this year based on the circumstances.

The four recipients, ranked by the committee, are as follows:

I also sent a note to the other 66 applicants thanking them for their interest and efforts in applying for a CASI scholarship.

I believe that we had a very successful second year of the scholarship program and that it will continue to grow in the future. Applications were received from Arizona, Colorado, Illinois, Michigan, Nebraska, New Mexico, Texas, and the Virgin Islands. The word is getting out via the Pods and Great Peppers. A great big thanks to all of you!




## Easter Trash Pickup

# Pepperdean's Pondering

Welcome to May! After hibernating for the winter months here in the East, the spring cookoff season is under way, and we're havin' fun.

As CASI Pods, we are obligated to promote CASI and chili cookoffs in our respective areas. I believe, though we have unique challenges in our different locations, many of us face similar problems. Not very long ago at the Mason Dixon Pod, we had only a couple of Maryland cookoffs and very few Maryland cooks. This was not satisfactory. Now we are well on our way to being a 12-point state, we are gaining new cooks each year, and chili enthusiasm is way up.

Some of this growth has come from marketing through the Internet, as I discussed in a previous column. This month, I'd like to share another of our fun programs with you: the Mason Dixon Pod Championship series. It's simple and easy for any Pod to do. All it requires is for someone to do a little record keeping.

We wanted to find a way to reward Pod members for coming out to more cookoffs, for helping at cookoffs, and for bringing us leads for new cookoffs. We also wanted to spur a little friendly competition between Pod members. To do this, we established the Pod Championship Series where we award Pod Points for the following:

Pod members will accrue points on the following basis at each Mason Dixon Pod supported cookoff:

Entered and cooking - 1 point

10th place - 2 points

9th place - 3 points

8th place - 4 points

7th place - 5 points

6th place - 6 points

5th place - 7 points

4th place - 8th place

3rd place - 9 points

2nd - place - 10 points

1st place - 11 points

Organizing an ongoing cookoff - 5 points

Organizing a new cookoff - 10 points

Conducting and participating in a chili cooking seminar to promote a

cookoff - 5 points

Head Judge - 5 points

Table monitor - 5 points

Referee - 5 points

Entered and cooking or acting as an official in a Mason Dixon Pod-supported cookoff outside of Maryland/DC/Virginia - 5 bonus points in addition to placing/helping points.

Only Mason Dixon Pod members will earn points. Cooks joining the Pod mid-year will accumulate points from the start date of their membership.

We plan to award the Pod Champion a plaque and \$100 reimbursement of their TICC expenses.

This is how we do it. For next year, I'd like to add something for someone who brings a new cook to a cookoff. We're just five cookoffs into our first year of this program, and we already have new cookoffs and new cookoff helpers. Even better, we're starting to hear comments like, "Hey! How did she get all those Pod Points?"

I've written a simple program in Microsoft Excel to easily keep track of points. If you'd like a copy, send me a note and I'll send you a copy of it.

## Chili Bites

The first cookoff that I attended was in Blanco with a friend who was a member of The Country Bumpkins chili team. It was quite an experience.

I met Joanne and Richard Horton, Shorty Fry and Yeller Dog and Nan. I might also add, it was an exciting cookoff. A man parked close to us had a gun out that was not loaded - so he thought. He pulled the trigger to show that it was not, and found out it was. As the bullet came our way, I did the fastest duck behind a car that has ever been done. It went over us and landed in a car parked behind us. I almost decided to give up chili cookoffs for good, but am glad now that I didn't.

Cookoffs were not as serious then as now. You cooked, you either won or lost, and then you partied. The point system was a necessary 6: 3 for first, 2 for second and 1 for third. 4th through 10th places did not receive points. Duff and our daughter, Terri, qualified for Terlingua on the 6-point system.

Getting back to Blanco. There was a band after the cookoff, and this man in a pair of overalls grabbed me and off we danced. Unfortunately, he didn't dance any better than I did. This was Yeller Dog. When we stopped before falling, I met Joanne and Richard. I still remember they were wearing Willie Nelson t-shirts. I got to know Shorty Fry, too, and we spent a lot of time together at cookoffs over the years. I had a lot of fun with this group for many years. When I got home I thought about my day and decided that chili cookoffs were a lot of fun with a lot of very friendly people. I still feel that way today.

Some of those that were around then are not cooking anymore. I guess they have grown up. Others have left us for a better place. Many are still around, still enjoying cookoffs and all of the many friends that we have bonded with over the years.

There were not any cookoffs in Blanco for many years. I can see why as that much excitement would be hard on a body.

This also reminds me of another cookoff that I went to in New Berlin. Pat Moriarty dressed up as a bunny. He would hide behind the fence and when a car came by would pop up. I saw at least one car turn around and go back the way it came. They probably couldn't believe they really saw a bunny lurking behind a fence, or maybe they had too much to drink the night before and thought they were seeing pink bunnies instead of pink elephants.

We arrived at the New Berlin Cookoff after having been pulled out of the mud at the Houston Pod Cookoff at Bear Creek Park in Houston. We decided since we were out that we might as well go on to New Berlin that night and cook on Sunday. A motley crew of us stopped at the store to get things with which to cook. We had people following us around to see what we were buying as we discussed it with each other in rather loud tones - the finer points of meat, tomato sauce, etc. I can't remember if any of us placed, but we did have fun.

That reminds me of something else. We were with the El Jefes' in New Orleans for the World's Fair to cook chili against cooks from New Orleans. In those days there were not many chili cooks, so we were really cooking against chefs from some of the restaurants. While in New Orleans, we went out to eat at a nice restaurant. We behaved at dinner. How about them apples! After dinner was another story, however. We decided to take a trolley back to the hotel after one of us walked into a light pole, and no, it was not I. In the trolley, we were sitting all over and someone (again not me) decided that we would hijack the trolley and take it to San Antonio. We discussed it from the front, sides, and the back. No one got off; they probably couldn't decide if we were crazy or not and didn't want to risk getting off because of what we might do. I will never understand why people don't trust chili cooks. We do some silly things but we are honest, law abiding people. At least, I think so. We really wouldn't have hijacked that trolley. A trolley can't fly; we knew that. We are not stupid after all. We decided we

By the time you get this, Ladies' State will be over. I will congratulate all of the winners now. (Nothing like doing things early.) I also want to thank all of the workers that volunteer their time to this cookoff every year. It is hard work.

I guess that is it for this month. All of you get out there and get those points. I know that most of you will be at Terlingua anyway, but it is much more fun to be able to cook. So cook that meat, mix those spices, and drink that beer or whatever drink strikes your fancy.

# The Tejas Medicineman Presents: "Chili Chants" - Let's talk about

What's in your chili case? Or, you might ask, "what's a chili case?"

Most every cook carries some sort of case with them to a cookoff that has most the essentials that will be needed for the cookoff that day. A chili case has taken the form of a lowly cardboard box, yea, even a paper sack, all the way to a custom wooden hand-built brass-hinged carryall locker. Over the years, it has been interesting and amusing at times to see some of the cases and some of the contents that are carried to cookoffs. It has been just since the new century that the cheap plastic tote boxes made their appearance at cookoffs. The Rubbermaid Company has created some of the most useful and rugged of the lot.

First a little history. The earlier of chili cookoffs, as we know chili competition today, was mostly done out of the back of the trunk of a car or off the tailgate of a truck. More than 90% of the cooks did not have campers and motor homes and pitched tents or slept in, under, or around their vehicles with nothing more than a bedroll. Those times with campfire gatherings, songfests, and tale swapping were the beginning of many of the still close friendships that exist today in the chili world.

As time went by, the contents of chili cases migrated to the cupboards in motorhomes and trailers, and chili cases were not seen very often. It was just the new cook or a cook that did not own a camper that carried the chili case to cookoffs. It usually got interesting when a dyed-in-the-wool motor home cook would have to do without their motor home while it was in the shop for repairs. There was always something that was forgotten that had to be borrowed to fix the pot that day. The makeshift "chili case for the day" was always lacking.

The original basic chili case was dedicated to just carrying one group of things: chili powders, spices, and basic other mixin's. Most chili cases were just open wooden boxes with handles on them. Nestled inside would be jars of chili powders, glass spice bottles, a box of salt, assorted types of white and black pepper, onion and garlic powder, and stuck in one corner - a set of measuring spoons. The earlier contest winners were very secretive about their recipes and did not want anyone to know what type of mixin's they were using. They would collect themselves a matched set of screw lid jars and label and fill them with their own special blends. Some crafty cooks would deliberately put in a "decoy" or two just to throw off snoopers. The chili case was closely guarded, and it was sort of understood that you did not explore a chili case unless invited. The more experienced cooks would purchase their powders in quantities and keep them refrigerated, only taking what they needed for the day in the jars in the chili case.

Next month we'll continue looking at the evolution of chili cases, but mean while, I want you all to do some homework. Those that have access to the Internet, go to www.pineywoodspod.com

Look for the section, "For New Cooks". Click on it and then find the section on "Preparation". There you will find a 28-page book on "Preparing Competition Chili".

This was written by one of our all-time favorite cooks, Ray Calhoun. While this dissertation was first published years ago, the information is timeless.

# The Chili Frontier - Part 5

Now we start doing one of the more difficult tasks in starting a new cookoff in a new area - finding the people to cook. There is no easy way to accomplish this task; it takes time, talking to people, and getting out in the new area.

Where do you think you might find some people that at least like chili? Well, how about a local lounge? Not a bad idea. Even better when you walk in and see a pool table and maybe darts and shuffleboard. Start out sitting at the bar, because the bartender will notice you're new and ask where you're from, what you're doing in town, or something along those lines. Irespond, "I am trying to meet people that like 'chili'". Or you could say, "Do you know any place in town that serves good chili?" Or how about "I collect chili recipes and wonder if anyone has a good one." Whatever you use, hang on cause there will be people coming up to talk with you. I say this is one of the more difficult tasks because the more people I having talking to me, the more I have to pace myself drinking beer. Also, don't try to visit all these type places in town the same night. Spread them out (for obvious reasons).

You can find sponsors, as well as potential cooks, in these local establishments. The interest level might be such in some places that you have to go back a couple of times. The next trip, take a copy of the Terlingua Trails or the Goat Gap Gazette. Each time you visit, take something different to build their interest. This is nothing more than basic public relations, marketing, sales, or whatever you want to call it.

Oh yes, at some point the chili with beans/no beans discussion becomes alive and well. Tell them why chili has no beans in it. It's a great story or at least sounds authentic, and they will agree with you in the end. Talk chili, talk chili cookoffs, and tell them what is going to happen in their town – A CASI CHILI COOKOFF. I still have lots of other things to do looking for cooks, and next month I'll go over some of them.

It just so happened that Doris Kitterman (now Coats) was also participating at the TICC and brought her teenage daughter, Dusty, and Dusty's then boyfriend to help with the show team. Mike had seen the young Miss Kitterman around at local cookoffs, and they knew each other and had talked but were no more than just friends; but Mike noticed that she was there. The bustle and preparations of cooking, showing, and generally having a great time gave no hint of the lightning that was about to strike!

Now according to Mike, it was another one of those clear, moonlit, magical nights for which Terlingua is famous. The activities of the day were over (and oh yes, Mr. Sweet won 2<sup>nd</sup> place that day), and people were congregating at the top of the hill at Glen Pepper's Ranch to listen to and sing along with Kent Findlay and the High Cotton Express.

Mike and Dusty found themselves walking up that hill, alone, together in the moonlight under a dazzling clear sky. His girlfriend and her boyfriend had already gone up the hill to join the group.

She was wearing blue jeans and a turtleneck. (Does Mike remember that night? Oh yea!) And it happened. The KISS! "There was no premeditation, no pre-planning, it just happened" Mike said. # Terlingua, The Horse

Johnye had a request in January from Patricia McQueen in Massachusetts wondering if Terlingua posters were available. Johnye started an email exchange with her and found out some interesting information. Below is Ms. McQueen's narrative of Terlingua (the horse).

"Most of the info is old news, really, at least from the horse racing industry standpoint. It would be interesting to see how may people familiar with the chili cookoffs know about the horse. Certainly people following horse racing back in 1978-79-80, myself included, learned about the chili cookoffs, because there were the inevitable "where did her name come from" questions.

"Terlingua is a Thoroughbred horse, born in 1976. You may have heard of her famous sire, Secretariat, who raced in 1972-73. She was one of the first of his offspring to do well on the racetrack. Texans owned her, and she was of course named after the city where the chili cookoffs are held!

"Both horses currently live at Overbrook Farm in Lexington, Kentucky. Terlingua is getting older (just turned 26 years), and was retired from breeding a few years ago, so she just enjoys the good pasture life. Storm Cat is, obviously, still a highly desirable active breeding stallion.

"My reason for wanting one of the Terlingua posters is that this mare is very special to me. I've been lucky enough to see her a few times. I grew up watching Secretariat, and have been hooked on horse racing ever since. And because Terlingua was one of his first good daughters, I fell in love with her.

"After all these years, I recently saw a Terlingua poster in one of the Chili's restaurant locations. That's what made me start to pursue this whole thing. You'll notice the years I mentioned initially are the year she was born and her racing years. But really, any old year would do quite nicely, and I'd be forever grateful."



Under the column title "Support" you will see the option called "Download Acrobat Reader". You must now left click on this item. Once you have done so the download page will appear. Towards the bottom of this page you will find and left click on the item "Get Acrobat Reader Free". When you left click on this item the download page will appear. This page will provide you all of the instructions you need to load Acrobat Reader on your computer.

Once Acrobat Reader resides on your computer the reading of your advance copy of the Terlingua Trails is quite simple. When you receive the e-mail that contains the "pdf" attachment, simply left double click on the attachment and the next thing you know the front page will appear.

# Submitting your Ads and Pictures for Use in the Terlingua Trails

When you submit an ad fur use in the Terlingua Trails to advertise your event it is very important that the quality of that ad be as good as possible. If you mail us your ad, using the US Postal System, your ad should be bright and clear. A camera ready photo will provide the best quality. You should then put your ad into a large envelope so that you don't have to fold it. When we scan an ad that has been folded, the fold will show up as a distorted line. I would also suggest that you put a light piece of cardboard in the envelope to protect your package from being accidentally folded while in route to us.

You may also e-mail us your ad if your have it a magnetic format. The best format for us to use if a "tif" file using "cmyk" color format. The larger the image you send us the better. We can always make an image smaller, but if we try to enlarge an image it will become distorted.

If you take a picture that you would like to see in the Terlingua Trails there are a few basic rules you need to follow. First, make sure that the object(s) of your picture fill up your picture. Pictures of a distant group or object will appear very small when published. The brightness of your pictures is also critical. For the best results your picture should be bright and not contain any shadows. Caps and hats will cause shadows if the light hits the person from the wrong angle.

As a CASI Pod you are required to put on a pod cookoff once a year. To help you advertise your pod cookoff we allow each pod to place one quarter page ad in the Terlingua Trails, each year, free of charge. This ad should run the month before your cookoff occurs. # "A View Fron The Top of An Old Chilihead"

I'm writing this article a week before the Texas Ladies State Championship - CASI is to be held under the beautiful pecan trees at Starcke Park in Seguin, Texas. I have recently been asked several questions about Ladies State, Southwest Ladies Regional etc. So I decided to change my article for this issue and write some of the history of these cookoffs.

We all have memories of the past and each of our reminiscences are different from each others. But, the past is history and to progress we must live for the future. History is based on fact and documentation. So let's delve into the past and review a little history of the Texas Ladies State Chili Championship.

Hondo Crouch started the Ladies only cookoff in Luckenbach in 1971 so the ladies would have their own cookoff in response to the men's cookoff at Chilympiad in San Marcos. When Hondo passed on, Luckenbach belonged to Kathy & Ken Morgan and Ladies State became their responsibility to continue. Kathy limited the cookoff to only fifty (50) cooks. A lot of ladies were left out. It helped to get in if you knew the right people. In 1978 C.A.S.I. was created as an organized and incorporated organization. I wrote the first official rules in 1978 based on what the cooks said they wanted. The rules were created to make cooking chili fair and equal for all cooks. The only reason CASI was organized was to protect all cooks and see that they were all competing on a level playing field. If the promoters had run all cookoffs fairly, or even 85/90 percent of them, CASI would never have become a reality. CASI would have remained a state of mind. Chili cookoffs and CASI would have faded away. CASI as we know it today would not exist. In 1979 all cookoffs had to use the CASI rules to be sanctioned to cook in Terlingua. Kathy Morgan would not change the 50 only limit. Although several cookoffs had reservations about the new rules and organization they went along with CASI. Frank Tolbert, Paul Smith and I met to discuss the chili year. Luckenbach was the only problem we had in conforming to the new chili rules. Frank Tolbert said we could not recognize this cookoff. If you knew Frank, that was not the normal outlook for him. Frank said 'Let's start another one for the ladies and call it "The Southwest Ladies Regional Chili Championship". The ladies can qualify in this one for Terlingua. Now that sounds like the Frank we know

We were running out of time to get a cookoff organized and put together for the 1979 Terlingua World Championship. Terlingua was the second weekend in October at that time. We had approximately three to four weeks to find a site and organize

this event. We met at my home in Dallas. Doris Kitterman, Richard and Carol Knight, Paul Smith and Judie and I were there. Frank had commitments that prevented him from being there. Tolbert was smart and dodged as many work details as possible. We made plans, formed the KKK Productions (Kitterman, Knight, King) to run the cook off. We put up the start up money for the cookoff. Doris was our treasure. She went to her bank and opened an account for KKK. Her bank was reluctant, but did open an account. That night the police came to Doris' house to question her. We put the cook off together and held it at the stockyards in Ft. Worth. Even with the limits, frustrations and pressure it turned out to be a good cookoff. The theme was pink and pink is still used today at Texas Ladies State. In 1979 and 1980 CASI had Southwest Ladies Regional Winners, but no Texas Ladies State Champions recognized by CASI.

In September 1980 we held the first Great Peppers meeting at Paul Smith's ranch in Weatherford, Texas. It was by invitation only. Great Peppers, spouse, Hal John and Judy Wimberly, Frank Tolbert, plus the CASI referees and officers of CASI attended. This was the first opportunity for the Great Peppers to present their proposals for additions or deletions to the CASI rules, this would be for the 1981 rules. Houston was there in force to protest the Luckenbach situation. Jim Atherton was the Great Pepper and their spokesman. The first question I asked Jim was if Kathy Morgan was willing to lift the 50 cook limit. He replied that she would. I said 'great"! Without the limit the Texas Ladies State Championship will be recognized as a sanctioned CASI event. I'm looking forward to returning. Next proposal please. Poor Jim was left speechless. He had came for a fight and did not have an opponent. CASI needs to remember Jim for what he did do that day. He proposed that every cookoff start sending CASI fifty cents per cook to help pay the expenses of CASI. The Great Peppers agreed and then I was almost left speechless. Up until that time Paul Smith and I had funded all of the expenses for

As a side note on Luckenbach. I still attended the Hug-In in February those years when there was no Ladies State recognized by CASI. I don't know if I was stupid or masochistic. I thought I needed to let people know what the problem was. Besides, Luckenbach was a great place to go for a large time. There were a lot of beer drinkers, dope smokers and guitar pickers. No, chili cookoffs today are not the same. Is that all bad?

The Texas Ladies State Championship was returned to Luckenbach in 1981. Everyone ws happy for several years. This is a very brief synopsis of

what transpired without going into the long drawn out details of the negotiations. In the late eighties the ladies began to get irritated with Luckenback and the State Championship. They did not get the recognition accorded the men at Chilympiad. There were no neat goody bag items. None actually (unless you count a jar of Blue Star Ointment). They never knew what the trophies were going to be. One year they were made out of cardboard glued into a pyramid shape and spray painted. The ladies were unhappy and CASI had nothing to do with it. As the old saying goes "Hell hath no fury like a woman scorned". The ladies wanted to move the cookoff and have a committee run it like the Mens State. Rex Jones was the CASI president at that time. He said CASI would do what ever the majority of the women of Texas wished, but it was it was their decision. Numerous meeting were held in Texas for the ladies to come and make their recommendations and to suggest what they wanted. They did and their decision was to leave if Luckenbach would not meet their needs and wishes. Luckenbach would not agree, so the cook off was moved. Rex had promised to work with them when they made a decision. A site was needed. Everyone knew that Seguin had a terrific location in Starcke Park for a cookoff. Most of the women were familiar with the location from attending the Classic Pod cook off there in years past. Rex Jones called Pat Irvine and asked if Starke Park would be available for the women. 
