High Noon at TICC

If things appear a little tense on Saturday, it's okay - they are. In August, I begin cleaning up the judges' invitation list from the previous year and mail out letters and response cards. This year, 638 invitations were mailed with a response from about 400. We request that judges register on site Thursday and Friday to double check those who actually make the trip to the Ranch. Approximately 80 judges did not pick up their badges this year and therefore didn't proceed to table assignments on Saturday. The past 5 years, we have worked the judges' list enough to use the public, some non-qualified cooks, sponsors and dignitaries to fill the judging tables on Saturday. So many of our judges return year after year; some even date back to judging at Villa de la Mina. They come from as far away as Maryland, New York, Florida, the Carolinas, Nevada and California to name a few, just to judge some of the best chili in the world.

But, back to Saturday, as this is when the word tense becomes "AMAZE-MENT". At high noon this year, 309 chilis came thru the judging area gate; 150 judges were seated at preliminaries, 30 table monitors went to work giving instructions to the judges, 8-10 event staff counted and reshuffled the cups. There were kitchen staff to serve up beverages and computer people were in place. All this was done within 10 minutes after the chilis were turned in.

The stage has been set for Jim "Dog" Luhn to work the numbers and have everyone in place so the chilis that advance move quickly and without delay to the next level following preliminaries. When chilis don't advance, the tickets are pulled by Risa Ray who accounts for them until all levels have been judged. The numbers are posted for your benefit after announcements are complete. Tables average 10-12 chilis to be judged at each level until the final round is reached, and this year the final table had 20 chilis judged.

All the staff and volunteers do an outstanding job each year and are greatly appreciated by Jim and me. We couldn't perform this amazing task if it were not for their help. In closing, one of my favorite sayings surely sums up High Noon at TICC, "Your only as tall as the shoulders you stand on"; this is so true.

Two weeks before Terlingua this year, I made my monthly visit to the specialist who treats me for FIBROMYALGIA, and as always went through the routine things before seeing the doctor; weight, blood pressure, questions, etc. Well, this visit, my blood pressure was high enough that it alarmed the nurse and even alarmed the doctor more when she re-checked it.

Her first question to me was, "Does your family doctor know your blood pressure is this high?" I told her, "No, I still don't have a family doctor." Lamar is not overly blessed with doctors, and many we do get come in for 6 months to a year and then go on to greener pastures. We do have a few for a small town. I guess my thinking was when my family doctor retired about 6 years ago that I wasn't going to be sick any more except for the fibromyalgia.

Due to a cancellation and my condition, Dixie was able to get me into a local doctor the next day for a check-up. My blood pressure the following day was 204 over 124. The funny part of this is, I felt fine all except for the Fibro. Here I am with blood pressure placing me on the borderline of a Class # 4 Stroke, and we are traveling all over the country cooking chili. The doctor immediately put me on medication that I will take the rest of my life. It brought my blood pressure down to the range allowing us to be in Terlingua this year. So PLEASE keep track of what your blood pressure is doing.

Bess told me I had to keep this short because of her recipe, so my update on El Nino will have to wait till next month, and yes, it is coming.

PUMPKIN BREAD

3 Cups Flour 1/2 teaspoon Nutmeg

1 teaspoon Soda 2 Cups Pumpkin (1 can will work)

1 teaspoon Salt 4 Eggs 3 Cups Sugar 1 1/4 Cup Oil

2 teaspoon Cinnamon 1/2 Cup Chopped Nuts

1/4 teaspoon Allspice 1 Cup Raisins

With mixer, beat eggs and slowly add sugar and beat until light and fluffy. Add oil, pumpkin and mix. Mix flour, soda, salt, cinnamon, allspice & nutmeg. Then mix into egg mixture & blend. Add raisins and nuts. Fill four (4) coffee cans (1 pound) coated with Pam. Bake 1 Hour @ 350 degrees. Remove to rack to cool for about 15 minutes.

Remove from the cans and completely cool. Wrap in Saran Wrap to keep moist.

Contests for all categories were held at the judging area. Great pictures! Friday was the hot wings, beans and salsa contests day.
