An open letter to Great Peppers:

As I begin preparations for the Great Peppers' Meeting and reflect back on the past months, I see one nagging problem that we need to work on together. This is something that has been a constant companion of mine for the past seven months. It's old business that should have been wrapped up a long time ago.

Here's the problem: We are still trying to determine the status of several pods. Some pods have not completed or communicated the credentials criteria that were due prior to their seating at the Great Peppers' Meeting last September. Lack of response from some Great Peppers makes it impossible to verify the existence of some pods. This is a situation that cannot continue; it interferes with the daily work of CASI.

Let me remind you of the criteria for a CASI pod:

Work to promote chili through CASI

Maintain a paid membership of at least twenty-five members

Hold an annual election of officers

Hold a CASI pod cookoff each year

The Great Pepper or authorized pod officer must attend the Annual Great Peppers' Meeting.

There is a consensus amongst the Board of Directors that each pod should live up to these requirements. As Executive Director, I am most concerned with each pod having a dedicated group of people working to promote chili and CASI cookoffs. We can work with some situations, but others are not acceptable. We hear stories of "pods" with no meetings, no officers, and no elections in years. We hear of pods that have a proxy delegate at the Great Peppers' Meeting but have no list of officers and never meet. We hear of pods with no membership and only a Great Pepper who attends meetings. Note, the CASI By-Laws give the Board of Directors the authority to suspend any pod not meeting these requirements and to take away all of their privileges and sanctions.

Please understand that our goal is the growth of CASI. We are not on a witch-hunt to force people to go away. The purpose of this letter is to give you ample notice to make any necessary repairs to your pod activities and to document them so you can submit your credentials in time for seating in Little Rock. Please schedule your elections in time to send in with your credentials packet and remember - pod officers need to be paid up CASI members. We will review the 2003 Great Peppers' Meeting Pod Credentials Forms very carefully. Please do the same and make sure they are complete and accurate.

We would like to ensure that all of the pods seated in Little Rock are sincerely working for CASI and chili, and they have completed their credential requirements prior to the meeting. I'd like to emphasize that the key measurement here is the promotion of chili through CASI. I'll gladly take Credential Forms prior to pod elections, but please get the elections completed and send those results to me in enough time for them to be certified prior to the meeting. If you have any questions about how to meet these requirements or if your pod is in decline, don't hesitate to contact me. I'm ready to help. 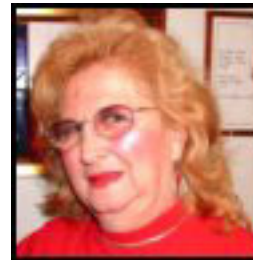

Bess's Best

Hello once again to everyone from beautiful and windy Lamar, Missouri. It feels so good to be up and going again. We have been back out on the Chili Trail for about a month now attending three cook-offs. At all three cookoffs we encountered bad weather, and in fact, at 2 of the 3 we had tornados.

We cooked in Frontenac, Kansas, on the 4th of May, and a tornado hit and completely destroyed Franklin, Kansas, which is about 5 miles north of Frontenac. I guess the "Chili Gods" were watching over us, because the storm struck about 2 hours after turn-in and many of the people and cooks who attended had left for home.

There was concern for a while about one of the cooks who lived in Franklin, but contact was made with him a day or so later. He lost EVERYTHING but he and his family are all right and escaped injury.

Then with that still on our minds, we went to Oklahoma City this past weekend to cook. Yes, you guessed it; we got in on the tornados that hit Oklahoma City on Friday night before the cookoff. All of the tornados (9) stayed a few blocks north of us but that sure gives you a funny feeling when you hear the tornado sirens, especially being in a strange town with which you are not familiar with the locations they give you as to where the storm is and where it's going.

Maybe some of my hard-earned savings are starting to pay off. Harry is getting to where he is fairly correct on his weather forecasts, but it will be a while before you see him on The Weather Channel. During the two hours that we encountered the storms, I think Harry spent as much time or more outside of the motel room than he did inside with me.

There were two storm chasers who stayed in the same motel that we did. For those who know Harry, you know he has never met a stranger. While he was outside watching the sky and weather, he went down and became acquainted with and spent most of the night talking and watching storms with them.

At his insistence, I did consent to go down and look at the vehicles the storm chasers travel in. The equipment the vans have in them would rival any of the local television stations around the Lamar area. Harry told me that these two storm chasers had traveled over 7,000 miles in Oklahoma and Texas following storms since the first of May. They were going to follow this particular storm front into Illinois.

Then there is always the sad side to any bad situation like the tornados we have experienced in the Lamar area. Tornados have taken the lives of two local people since December.

As I mentioned in opening my column, it's wonderful being back out in the chili world. I guess I didn't realize how much Harry and I missed chili and our chili family. When lay people (others who are not familiar with chili cookoffs) ask me what there is about chili cookoffs, one of my favorite ways of describing a cookoff is "It's just like a Big Family Reunion".

I sort of felt sorry for Harry and decided not to cook for a while this year till he gets qualified (but really I am a better cook, because I always beat him), so I have spent these three cookoffs catching up on everything that has happened in the chili world and with our chili family over the past 7 months.

School will be out in a few days and not having the grandchildren the amount of time we have them now will allow Harry and I to get out and attend more cookoffs. The grandkids have mentioned that they would like to go with us to cook some weekends, but we have a problem with that. Our granddaughter gets carsick when she travels with Harry and I. We have taken her to the doctor and she has medicine, but when she travels she gets carsick. Harry said it's my driving that makes her sick and that my driving would make anyone sick.

Never say never! Last year a church in a nearby town contacted Harry and I about cooking chili as a warm up to a wild game feed they hold each year. They offered to furnish all the supplies, so we said yes and cooked enough chili to serve 1000 - 4 ounce servings. Afterwards Harry and I said we would never tackle anything that large again, but as I said, "never say never". Last week before leaving for Oklahoma City, I received a phone call and they want us to cook and serve again this year.

Only this year they want to try and serve 2000 cups, and yes, we are going to do it. Cooking, packaging and refrigerating that much chili will consume the better part of a week. I know doing something like this is a lot of work, but Harry and I feel God gave us the talent to cook chili and have not turned down a group, organization, school or church and will continue to cook as long as we are physically able.

After being in storms for two weekends, our son and daughter seem to think we need to get us a cell phone. I guess that is one of the gizmos or gadgets that we don't have. From the looks of everything, Harry and I must be behind the times. It doesn't matter where we go now; the cell phone is the thing. Seems like just about everyone is either carrying or talking on one - walking, riding on bicycles and in cars. I don't think Harry and I, together, know that many people to talk with that we need a cell phone.

But that might be like the computer. After the many years I spent with the Department of Agriculture using a computer every day, it was two years after my retirement before I got one. Now I have two laptops and one in the shop. Harry is down to three, but he has his tied in with weather and his schooling. Needless to say, we are some of Southwestern Bell's best customers.

Looking at the clock, I need to go to the grocery store before rush hour. Notice I said I NEED. Harry did the shopping while I was under the weather; our cabinets and pantry are full of ever so many items we don't need. I think that Harry must have bought the LIMIT of every item the store had on sale while he was shopping.

In closing I want to say - Thank You for Your Time Till Next Time & Remember To Start Slow and Then Taper Off.

The Tejas Medicineman Presents: "Chili Chants"

Apathy - it comes to all of us at one time or another. I took a minute to look up the word to try to get a clear picture in your mind and mine of the meaning of the word. "Lack of feeling and interest in things which others find moving or exciting." Today, we discuss apathy in chili politics.

During my tenure of over 20 years on the chili trail, I have observed the creation of three distinct Chili Societies. Two were already in existence when I made my first trip to Terlingua, Texas in the early '80s. CASI broke away and became the third entity. There were various reasons for the creation of the splits, but the details are not the gist of this article. What matters is that in every case a group of individuals decided that the leadership of the society had become staid and was not representing the original reason of forming the society and not setting a course that would steer the society into a long and successful future. Those individuals had seen the society members, as a whole, become apathetic. There was a stranglehold on the management of all the affairs of the society and the average members of the society felt helpless that nothing could be done.

Apathy - until (like the few brave souls who defied the King of England and founded our great Nation today) a few new brave souls broke away and formed CASI and became the first Board members.

The original intent of CASI was to have each of the Pods elect a Great Pepper who would represent their interests at the Great Peppers' Meeting each year. Through these Great Peppers, the original Board members who established CASI would be replaced with popularly elected members by a vote dictated from each of the Pods represented, which would take over the "executive mechanics of running the Society".

If you have been paying attention, you would ask, "So what's different today?" and "Are you suggesting something unthinkable is about to happen?" No, not at all. But I will say that the populous of the chili world has become apathetic once again.

The average member of the Society feels helpless to even suggest anything for improvement because their voice is lost in the wind. This does not have to be. The next few months are very crucial to the future of your Society. Now is the time when new leaders for each of your pods will be elected. This is no time for a popularity contest. This is the time for leaders to be elected who will steer true courses. This is a time when you can choose a trustworthy person who will represent the voted will of their Pod at the GP meeting and will not knuckle under to change their vote at the last minute and go against their own Pod's vote.

These GPs will not let themselves be dictated to or forced to comply with the assumed power of some existing Directors. They will caucus among themselves and find a common bond and will work with one another toward a unified goal.

This is also the time to take stock of who is the best qualified of your Pod to be Area and Regional Referees. Out of the masses of our Society will come new blood in the arena that want to try to make a difference. Those will be the new candidates for Board membership. They have until August 9, 2003 to submit their applications. (Go to www.chilicook.org to get the form.)

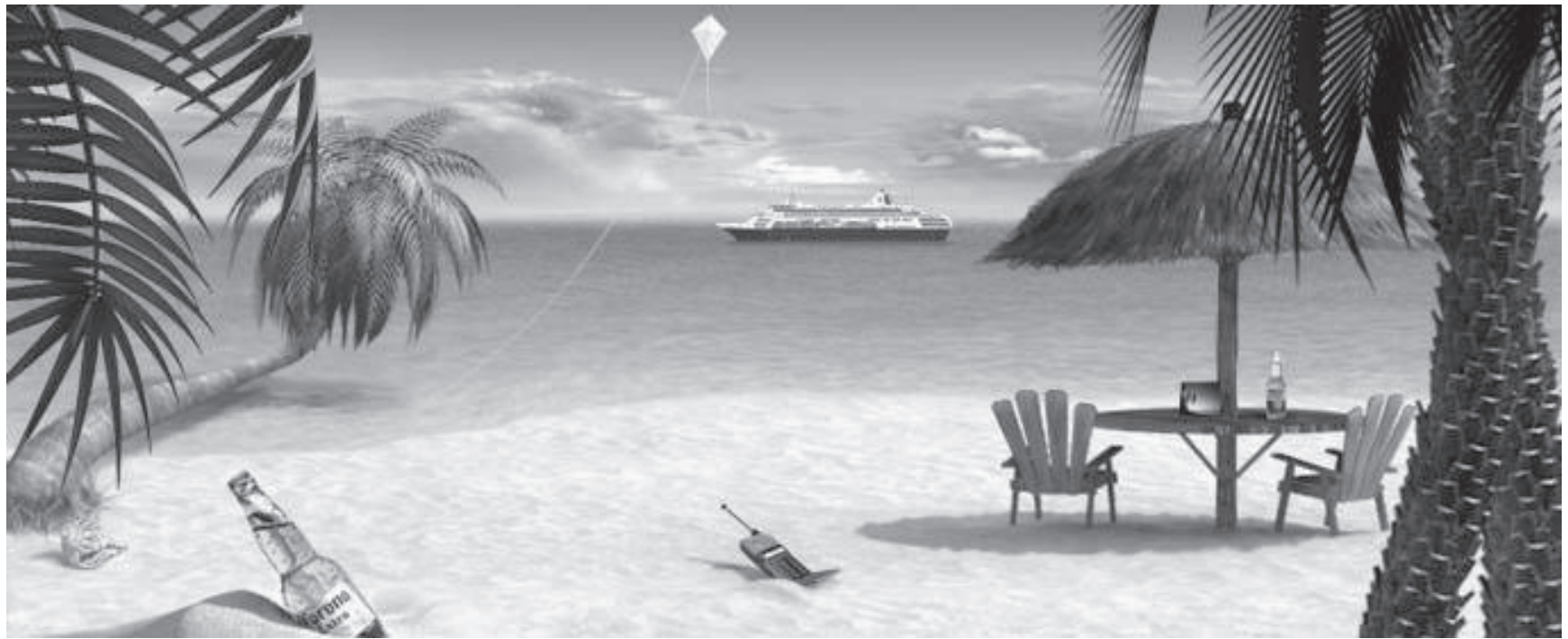

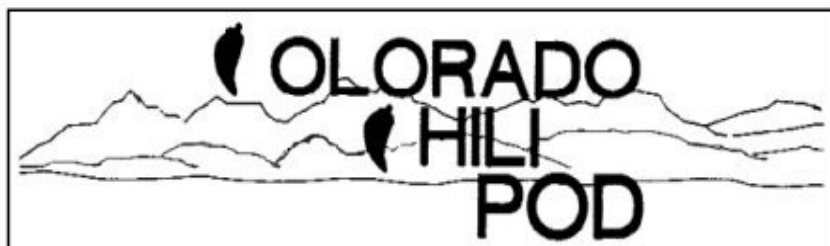
