All of the cooks went out of their way to make this a special event. Thank you to all who participated, planned, volunteered, sponsored, got up early - and oh yes - cooked.





## ED Ponderings

Two years ago after the election in Tempe, Jim Ezell shook my hand and said, "Condolences." He knew the position of Executive Director was very demanding and sometimes lonely. He knew that sometimes those who you believed were friends would behave badly because their egos were more important than what was right. He knew there would always be those who helped define the rules by testing their limits. He knew important initiatives would encounter obstacles because some participants would forget the best interest of CASI in favor of their personal

agendas

All of this is true. There are tough moments, but the good moments are in far greater proportion. The privilege of serving this wonderful organization and all of its participants – cooks, promoters, friends – has greatly enhanced my life and I am indebted to all of you. I am energized by the work and I am dedicated to continue to do my best to do what is right. CASI deserves nothing less.

CASI is composed of a large, diverse, spread out population with varied needs. I have enjoyed traveling to different regions, listening to the concerns and desires of cooks, promoters, and cookoff organizers. It is impossible to always meet these individual needs and satisfy everyone. I hope everyone understands that. My goal is to keep listening, learning, giving careful consideration, and making the decision that appears to be in the best interest of CASI. I also hope that if I make a mistake, I can recognize it quickly and get us back on track.

I have been accused of wearing rose-colored glasses. I assure you this is not true. I am the person who gets to hear about all of the "problems" from those who are unhappy. Still, I'm overwhelmed with the good deeds CASI is performing throughout the country and by the warmth and generosity of all of our members. There may be a little empty spot at the top of our glass, but let's all rejoice because our glass is quite full. We'll work together on the rest.

When I took this position, I was concerned with the adversarial tone of the rhetoric being heard. There were accusations that the Board of Directors failed to work together and, when they did, they worked in their own self interest. I think we've come a long way to settle that misperception. The only way to really know how the Board works is to attend one of their meetings. We have had an increased gallery presence at each meeting, and I believe those who have attended can attest to the hard work of the Board. I am proud that the Board members have worked together in a very professional manner over the past two years. We have tackled some very difficult issues and we have given them our best study and consideration. The best interest of CASI has always been our goal.

As I look forward, the following is a list of challenges that I think we need to address. Since our organization is spread all over the country and since we only meet together once per year, projects develop slowly. We must be patient and persevere because I feel the following are important to our future. They are listed in no particular order.

IDENTITY. We must always remember that WE all are CASI. CASI is not some thing or some person that takes care of us or solves our problems. CASI will only grow and flourish if every one of us invests ourselves in the future. It doesn't matter if you serve as a CASI official, a Pod official, a cookoff organizer, a cook, a supportive spouse, or in any other capacity. None of us are any more important than any other. We're all members of the CASI family and have a responsibility to one another. Everyone can help us become better.

CONDUCT OF CASI OFFICIALS. We need to assist CASI officials to do a more positive job. Most cookoffs that come to the Board for adjudication of problems do so because of the actions or inaction of the CASI official at that event. CASI officials need to be cognizant of the rules and to clearly follow their intent with the welfare of CASI in mind. They need to take this responsibility very seriously. CASI cookoff officials are the face of CASI to the public. The way they act speaks volumes.

We have begun a CASI Officials' Certification Program. We look forward to expanding this program, adding trainers so that it may be administered throughout the CASI world. We should consider the desirability of making this program mandatory for Referees once the program is available to all.

**RULES AND TRUST**. I believe we have a good set of rules that provide the framework for a standardized, fair way of regulating cookoff activities to assure fair competition. The challenges with it are that its length discourages some from reading it. Too many feel they know the rules because they have heard about them referred to at cookoffs and they fail to read them. The CASI Officials' Certification Program will help us with this.

The other challenge is that whenever a rules question is presented by the actions of individuals at a cookoff, the questionable activity always fits in the cracks between the existing rules. The 'chili lawyers' are so busy splitting hairs that we sometimes lose sight of the forest through the trees. Every time we have rules changes, we tend to make rules more specific, thus creating more gaps for the lawyers to argue. We have to keep the intent of the rules and our goals in mind. We need to use common sense.

When a cookoff problem reaches the Board of Directors level, we consider all of the facts that we have and act appropriately. We are not aggressive, but we have the courage to act when we must. CASI members can trust their Board of Directors to investigate, thoroughly discuss the pertinent rules and available facts, and to debate what measures should be taken.

We feel that there is no benefit to hold anyone up to ridicule by publicizing disciplinary measures, so we keep these actions quiet. This does not mean that we failed to act. CASI has a protocol in place and it is working.

**MENTOR PROGRAM.** We need to help new cookoffs, new Pods, and lost Pods to be more successful. I propose the organization of a mentor program to help. To any who would welcome the help, we could assign a knowledgeable person to advise and assist them to build membership, increase sponsorship, increase cookoffs, or whatever they would need.

**PROMOTION**. A popular phrase seems to be, "We're all getting older. Where are the new cooks?" The answer is, "the new cooks are out there in areas where the Pods promote chili and CASI." Unfortunately, too many Pods are not bothering to do their part. When the credentials form asked Pods to report what they did last year to promote CASI, 35% had nothing to report.

This brings us back to IDENTITY. CASI is all of us. Let's all get aboard, invest ourselves in the cause, and work together to assure a great future. I remain your dedicated servant in these endeavors.

## TICC Registration

All cooks and showmanship registrations for the 2004 Terlingua International Chili Championship will be behind the presentation stage on Thursday, Friday, and Saturday. The times will be Thursday, November 4, from 11:00 a.m. until 3:00 p.m.; Friday, November 5, starting immediately following the Old 320 meeting (approximately 10:30 a.m.) until 2:30 p.m.; and late registration Saturday, November 6, from 8:00 to 9:00 a.m.

"Heightened security concerns" have affected many facets of our daily lives, and TICC has not escaped these concerns. There are a couple of new procedures that will be instituted for this year's TICC registration. The registration tables will be set up with alphabetical stations, plus one for membership. Upon entering the registration area you will go to the station corresponding with the first letter of your last name and receive your name badge, judging cup, and contestant shirt from one of our volunteers. If you have not renewed your membership or need to join CASI, you should first go to the membership station to get your name badge.

In order to get your badge, you will have to produce a picture ID. So, be prepared. This procedure requires each contestant to register for themselves. If you have a physical condition that would prevent you from coming to the stage area, let us know and we will come to you.

If you are registering for showmanship only, you may bypass these stations and go to the showmanship registration table

Showmanship registration will be conducted at the same times as cooks' registration, except it will be by the Head Show Judge at a separate station. A picture ID will not be required, but current CASI membership is necessary.

A new method of distributing contestant wristbands to show team members will be implemented this year. Each small show team is permitted up to four (4) wristbands and each large show team will be allowed up to eight (8). However, only the Show Team Captain will be admitted at the gate. All other team members will be required to pay the gate admission and receive a spectator's wristband.

The Show Team Captain will supply the Head Show Judge with a list of team members. The team members may exchange their spectator's wristband for a contestant wristband with the Head Show Judge. They will also receive a voucher to refund their admission fee. The vouchers may be redeemed at the concession stand (not the beer side).

Our goal is to provide each Cook and Show Team Captain who participates in the 2004 Terlingua International Chili Championship with a contestant's shirt. It is also our desire to make sure the shirt is the recipient's correct size.

The desire to meet our goal will inadvertently result in excess contestant's shirts. These extra shirts will be offered to qualified Cooks and Show Team Captains who are unable to attend this year's TICC. Someone may pick up a shirt for you on a first come first serve basis at 3:00 p.m. on Friday for as long as the shirts last. The person you designate must present your qualification card, and your CASI dues must be current.





#### Child of Chili

There is an upcoming cookoff in Deland, Florida, and the organizers asked me to write something about how I got started and this is what I wrote. Hope you enjoy!!

My mom and dad went to their first chili cookoff in Grand Prairie, Texas, in 1976. They came upon a bunch of wild chili cooks and decided from day one that they were their kind of fun. They formed a chili team and named us "The Bottom of the Barrel Gang". Each weekend, mom and dad would drag me (5 at the time), my older sister, Lisa, 8, and my younger sister, Kristi, 1 1/2, across Texas to every chili cookoff they could find. Each Monday, mom would unload the van from the cookoff the weekend before, then on Wednesday night she would reload the van for the following weekend. It seems like we had a chili cookoff somewhere every weekend.

As I grew into my teens, I got involved with the junior cooking division. I won some and lost some. After I graduated from High School, I moved to Florida and became involved with other things and stopped cooking chili. Mom and dad called every weekend to let me know what place they got; they were still chasing points for Terlingua - the International World Championship Chili Cookoff.






